3. Certificate of Independent Bid Determination (SBD 9)

- 3.1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

4. REQUEST FOR QUOTATION FOR: SUPPLY AND INSTALL 6 X ALUMINIUM ROLLER SHUTTER DOORS

The South African National Space Agency requires a supplier to Supply and Install 6 x Aluminium Roller Shutter Doors in an undercover parking area at its premises in **Hermanus**, **Western Cape**.

BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

The Space Science Directorate of the South African National Space Agency is situated on 16 Hectares of "Fynbos" covered land in Hospital Street, in the suburb of Westcliff, Hermanus.

4.1 SCOPE OF WORK (TERMS OF REFERENCE)

- Supply and install 6 galvanised Aluminium Roller shutter doors
- Manual operation with securing pin (latchable)
- Vertical lift mechanism with guides / Tracks
- Colour white
- Lightweight
- Height Approximately 2400mm (supplier to take own measurements)
- Width 5500mm (supplier to take own measurements)
- Roller to be externally mounted to the building

NB Compulsory site meeting to be held on the 17 May 2019 @ 14h00. Failure to attend will result in bid being disqualified. Bidders who have previously attended the site meeting for this project do not have to attend.

4.2. EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R500 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.

Please Note: the above amount (R500 000) is not the Budget Amount for this Project but is the Treasury threshold for request for quotation (RFQ).

The procedure for the evaluation of responsive tenders is **functionality (quality) and price & preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria
 (Table 3) and the minimum threshold of 80 points explained below. A bid will be
 disqualified if it fails to meet the minimum threshold for functionality as per the bid
 invitation
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below
