3. Certificate of Independent Bid Determination (SBD 9)

- 3.1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
- a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed

any corrupt or fraudulent act during the bidding process or the execution of that contract.

- 3.4 This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

- (iii) methods, factors or formulas used to calculate prices;
- (iv) the intention or decision to submit or not to submit, a bid;
- (v) the submission of a bid which does not meet the specifications and conditions of the

bid; or

- (vi) Bidding with the intention not to win the bid.

H. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.

I. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

J. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.

4. REQUEST FOR QUOTATION FOR : INSTALL EPOXY FLOOR

The South African National Space Agency requires a supplier to install Epoxy Floor at its premises in **Hermanus**.

BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

The Hermanus Facility of the South African National Space Agency is situated on 16 Hectares of Fynbos covered land in Hospital Street, in the suburb of Westcliff, Hermanus.

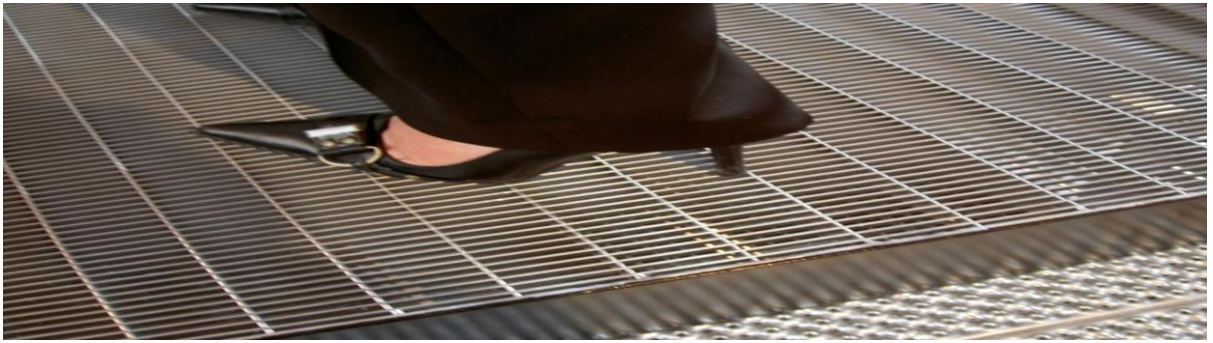
4.1 SCOPE OF WORK (TERMS OF REFERENCE)

Floor

- Remove existing floor (Bricks , tiles and paving)
- Apply self-levelling screed, floated to a smooth finish
- Epoxy floor installation should be between 38mm and 50mm to avoid bumps/ lumps (Lining up with entrance level)
- Floor colour – Light grey which include traces of blue, black and silver specs (Ratio: black 1 part + Blue 2 parts + Silver 5 parts)
- Include expansion joints in 3 meter intervals (North to South, East to West) totalling in 7 joints
- SANSA logos to be imbedded in epoxy coating and not painted on top x 4 (1 at each entrance blue – 1m [H] x 1.3m[W])
- SANSA logo to be imbedded in epoxy coating and not painted on top x 1 in centre of venue (blue – 2m [h] x 2.6 [w])
- Finished floor surface must be non-slip

Drainage

- Drop existing drainage system by 50mm
 - Outside :North wall (underneath paving)
 - Inside: Eastern and Western sides (trenches)
- Cover drainage system with grid similar to picture below (measurements to be confirmed at the site meeting)



- Grating must be a fine mesh
- Grid panels must be in two (2) meter spans for easier cleaning
- Installation of grids to be in line with finished floor level (FFL)

Please note that all work to be carried out on site in Hermanus and any additional costs associated with the site should be included in the costing.

Compulsory site meeting to be held on 17 May 2019 @ 15 h00. Failure to attend will result cancellation of bid.

4.2. EVALUATION CRITERIA

SANSA promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government’s transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R500 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable.

Please Note: the above amount (R500 000) is not the Budget Amount for this Project but is the Treasury threshold for request for quotation (RFQ).

The procedure for the evaluation of responsive tenders is **functionality (quality) and price & preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of **80 points** explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below

Eligibility Criteria

To be eligible for, price and preferencing evaluation, the bidder must submit the following as per table 2 below. Quality/Functionality:

Scores will be tabulated to 100 points. Respondents must score **70 points** and over to be assessed on their financial offer and preference score. The allocation of points for the evaluation of quality/functionality is set out in Table 3 below:

Evaluation Criteria 1: Company Experience

The experience of the bidder in epoxy floor installation over the last three (3) years will be evaluated – at least three contactable references to be provided.

The description should be put in tabular form with the following headings

The scoring of the tenderer's experience will be as follows:

Evaluation Criteria 2: Time Frame and Project Team

Bid should explain how they will manage to complete the project on time. A detailed installation plan must be provided indicating a timeline of the Project until completion.
