REQUEST FOR QUOTATION FOR ALTERATION OF TECHNOLAB PORCH LEVEL

SANSA is requesting potential suppliers to bid to provide alterations to the SANSA Technolab by Raising the floor level of Technolab porch (stoep) from the current level by 9 cm so that it is at the same height as the porch entrances of the Technolab. Please note that this RFQ is for work to be carried out at the **SANSA Hermanus** Campus.

BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

4. SCOPE OF WORK (TERMS OF REFERENCE)

SANSA requires a service provider to provide alterations to the existing porch of the SANSA Technolab building by raising the floor level of Technolab porch (stoep) from the current level by 9 cm so that it is at the same height as the porch entrances of the Technolab building. The Technolab is an existing building that is utilised for the Applied Science and Technology Laboratory as well as the SANSA Hermanus Boardroom. The building sees a variety of visitors throughout the year including stakeholders, clients, and members of the public. The building forms part of the SANSA Hermanus campus, and all work to be carried out on site in Hermanus. The SANSA Hermanus campus is located at Hospital Street, Westcliffe, Hermanus, Western Cape.

The alterations must be done to allow for easy wheelchair entrance into the Technolab building. The building has two porch entrances situated on the same side of the building There is an existing wheelchair ramp leading up the side of the porch.

The following must be taken into account:

- New surface bed to be laid with 20 mpa concrete.
- All outside edges are to be shuttered and finished in smooth plaster.
- The current wheelchair ramp must be altered to comply to regulations in terms of inclination and side wall height.
- The steps to the porch (stoep) must be altered to comply to regulations and the handrail must be removed and re-fitted accordingly.
- The top and side surfaces of the porch must be re-tiled with the same or similar nonslip tiles and with the same grout finish, including the steps. The side entrance steps must also be re-tiled with the same non-slip tiles.
- The side entrance handrailing to be replaced with stainless steel, the same style as the existing handrail in front at the porch steps.
- The lower anchor points of the outside shade cloth must be removed and re-fitted after the renovation.
- Touch-up plastering and painting as required.
- Any removal or alternation of brick paving must be restored on completion.
- Alternative weepholes must be drilled (±20)

- There will be a compulsory site meeting held on Wednesday 27 November 14h30
- Contractors must have a GIDB grading of 1 GB to be eligible to bid for this work. Proof must be provided with the proposal
- Should part of the project be outsourced, please submit documents of the outsourced contractor.
- No tools or equipment will be provided by SANSA
- SANSA will not store any equipment or tools
- Work to be done during working hours only (07h45-16h30 Monday Friday)
- All building rubble to be removed after completion
- SANSA will not provide any accommodation for out of town contractors
- Work must be completed to a high quality and finish as the porch entrances are used by clients and stakeholders of SANSA
- Bidders to note that the building will be in use during the alterations and the successful bidder will need to engage with the project manager to ensure minimum disruption to operations.

4.2. EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R500 000 (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R500 000) is not the Budget Amount for this Project but is the Treasury threshold for request for quotation (RFQ).

The procedure for the evaluation of responsive tenders is **functionality (quality)**, **price**, **and preference** method. The evaluation of the bids will be conducted in the following three stages:

Firstly, the bidder will have to comply with eligibility criteria as per Table 2

- Thereafter assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of **80** points explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.
- Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below.
