3. Certificate of Independent Bid Determination (SBD 9)

- 3.1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). 4. REQUEST FOR QUOTATION FOR: REFURBISHMENT OF ROOM T14

The South African National Space Agency (SANSA) invites service providers to submit proposals for **Refurbishment of room T14** at the Hermanus Campus in the Western Cape

BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

4.1 SCOPE OF WORK (TERMS OF REFERENCE)

SANSA invites service providers to submit proposals for **Refurbishment of room T14** as per the specifications below. T14 is a room within the technical wing of the Main Building on the SANSA Hermanus Campus. The room was part of the original building structure and currently has a suspended floor which attracts damp and makes it impossible for normal use. The intention of this RFQ is to refurbish the room to allow it to be repurposed and become useful space.

A compulsory site inspection and briefing will be held on 20 November 2019 @14h00. Failure to attend will result in the bid being disqualified.

SPECIFICATIONS

Phase 1: Floor

- Floor size approximately 36m²- measurements to be confirmed by supplier at the site meeting
- Remove storage shelving to clear the room
- Remove existing floor / solid wood
- Remove existing growth of algae
- Apply treatment to discourage the growth of algae in future
- Avoid water ingress by allowing sufficient waterproofing before filling the sunken area (now void)
- Fill void area
- Floor to be reinforced with fibre glass (non-magnetic)
- Screed entire room
- The finished floor surface must be level
- Aluminium inlays to be inserted in the expansion joints and has to be level with the finished floor level
- Allowance of doors should be taken into account when the finished floor level is completed as we intend using the existing door without any modifications to the door
- The finished floor level should consist of 600mm x 600mm black slate non slip tiles, with 5mm tile space between tiles
- Grout Dove grey

NB: The water table is high on the erven hence the contractor must take this into account when quoting on the job. Allowance must be made for sufficient wee-page upon successful completion of the works.

Phase 2: Partitioning of the room

- Dry wall partition to be erected in the centre of the room.
- Partitioning to be reinforced with plywood for hanging fittings
- Matching rhino cornice and wooden skirtings
- The partitioning should include two entrances; these entrances should be fitted with two sliding doors. The sliding doors must slide into the erected partitioned wall.

Electrical work

At least 8 x plugs per office - 4 dedicated and 4 normal backup plugs

Lighting

• LED tube lights – 1 x per office totalling 2, 1 x for passage

Painting

Interior of offices including ceilings to be painted in white.

4.2. **EVALUATION CRITERIA**

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R500 000 (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R500 000) is not the Budget Amount for this Project but is the Treasury threshold for request for quotation (RFQ).

The procedure for the evaluation of responsive tenders is **functionality (quality)**, **price**, **and preference** method. The evaluation of the bids will be conducted in the following three stages:

- Firstly, the bidder will have to comply with eligibility criteria as per Table 2
- Thereafter assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of 80 points explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation
- Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below
