3. Certificate of Independent Bid Determination (SBD 9)

- 3.1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). 4. REQUEST FOR PROPOSAL BBBEE SCORE IMPROVEMENT PROJECT

4.1 BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

4.2 SCOPE OF WORK (TERMS OF REFERENCE)

SANSA requires the services of an established and reputable service provider to assist with achieving a compliant B-BBEE score for a period of two (2) years. The service provider must be accredited with the South African National Accreditation System (SANAS).

The service provider must provide the following but not limited to;

- Do a gap analysis on the current B-BBEE status in order to identify key focus areas for improvement;
- Assist in the development of an appropriate strategy and action plan to improve the B-BBEE score (how to shift from current B-BBEE level of non-compliant to a desired level);
- Advise SANSA on options and how to best approach B-BBEE certification; such as compiling the applicable documentation in terms of the codes required to ensure points are awarded during verification;
- Advise SANSA on the new/updated B-BBEE codes and related legislation;
- Assisting and advising on compilation of the Enterprise Development, Supplier Development and Socio Economic Development plans including projects/initiatives that can be undertaken within the context of SANSA's 5-Year Strategy and Annual plans;
- Assist SANSA with identifying the Skills Development initiatives that will improve the score in this element;
- Assist SANSA to identify documents and other proof that will serve as evidence for the different elements of the B-BBEE scorecard;
- Guidance with file preparation for the B-BBEE audit;
- Assisting in problem solving regarding various B-BBEE issues across all elements of the DTI Codes as well as sector specific solutions;
- Provide SANSA with any other workable solutions relating to B-BBEE that will add value to SANSA;
- Workshop SANSA staff on the B-BBEE elements and the supporting documents required for verification. The service provider must be able to provide the workshops to all SANSA offices as and when required.
- The project will be managed at the Pretoria Office and only the workshops will be conducted in different worksites

5. EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R500 000 (all applicable taxes included) and therefore the **80/20** system shall be applicable.

The procedure for the evaluation of responsive tenders is **price**, **functionality** (**quality**) and **preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria (Table 1) and the minimum threshold of 80 points explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below
