## Introduction

This Addendum 1 with clarification notes serves to inform potential Tenderers of changes, amendments and clarifications made to the Bid documentation. The following queries and/or changes have been received from those that have collected documentation.

1		<p>Can you please confirm if this is a Panel appointment? If the panel is confirmed, can you please indicate your understanding of the duration of the estimated duration of each individual task. Or is the requirement that the successful bidder provide a developer(s) for the entire 12-month period with 3 days a week dedicated to SANSa in resolving any task on the project list?</p> <p>For both roles, there will be a set of business requirements that we need them to fulfil – we are expecting an artifact/s (e.g. portal application or system, set of geospatial products) to be constructed. Instead of waterfall model, we will be using an agile approach with sprints in-between where we can start delivering tangible value to the business much earlier. Performance of the developers (their outputs) will be evaluated on regular basis to ensure we will meet the ultimate goal/s (which is to produce a working application/system/products).</p>
2		<p>As a multi-national company, we might include developer(s) in our project team that are not South African Nationals. Can you please confirm if there are security restrictions which disallows foreign nationals or work being done remotely, not in South Africa.</p> <p>There are no restrictions in this regard. However, all activities will be performed within the scope of a contract (agreement) which will be signed by both parties. We expect the developers to adhere to this contract at all times. Confidentiality / Non-disclosure agreements and prior authorisation on communication (marketing) on certain projects engaged in will be required.</p>
3		<p>The scope of work indicates the service provision should ideally consist of either a Geospatial Developer/s or Frontend Developer/s who would be working on the project for three days a week, for a maximum period of 12 months. Is there a minimum period of time?</p> <p>We are flexible in this regard. In fact, we will really appreciate if the developers can complete the work much earlier (less than 12 months). To allow for agile planning, we will look at the scope of work and define key milestones to be delivered in shorter periods like every 3 or 4 months.</p>
