3. Certificate of Independent Bid Determination (SBD 9)

- 3.1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). Collusive bidding is a *pe* se prohibition meaning that it cannot be justified under any grounds.

The South African National Space Agency requires a service provider to supply and install a new UPS and move an existing one

4.1 BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

4.2 SCOPE OF WORK

Supply, deliver, install and commission the following

- A. 1 x Riello Aros MST80 80KVA 400volt 3 phase on-line double conversion ups system with additional dual Input conversion Kit and netman 204 in snmp with modbus over Ip
- 1 x battery stand with batteries for above with a back-up rating for 15minutes. With battery fused isolator.

Dc cable work for above included.

B. Disconnect, move, connect and commission the existing 80kva ups unit to the new shelter, provide for new rack for downrated battery set and provide for related DC cable work.

Work will be scheduled in two sessions to ensure continuity of supply to our customers. Details to be discussed during the project.

A qualified Aros technician must be commissioned for the job (supply proof of qualification)

This RFQ is accompanied by an annexure which is Shelter drawing with planned layout to plan for DC cable requirement.
