3. Certificate of Independent Bid Determination (SBD 9)

- 3.1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging). Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b.cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
- 3.4 This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

4 REQUEST FOR PROPOSAL FOR HIGH DENSITY FILING CABINETS

The South African National Space Agency requires the services of a suitably qualified supplier to design, supply and fit high density filing cabinets as a storage solution at the SANSA Hermanus campus in Hermanus in the Western Cape.

4.1 BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

4.2 SCOPE OF WORK/PROJECT BRIEF

SANSA requires a suitably qualified supplier to design, supply and fit high density filing cabinets, in the best possible way. The units will be primarily purposed for secure storage.

NB:

- 1. All proposed cabinets must fit in locations, dimensions listed below.
- 2. No tools or equipment will be provided by SANSA.
- 3. Successful bidder to supply all materials and labour.
- 4. The work required is on the SANSA Hermanus Campus in Hermanus in the Western Cape.
- 5. A compulsory briefing session will be held on 28 March 2022 at 12:00 at SANSA, Hospital Street, Hermanus to explain the current problem and provide any outstanding details.
- 6. Suppliers will also be given an opportunity (via appointment) to inspect locations on the site prior to providing a bid submission.

The SANSA Hermanus Facility is a magnetically clean environment and therefore all materials utilised MUST be non-magnetic and be confirmed by the project manager before use.

Background

SANSA Hermanus has three (3) available storage areas where groceries, stationary files and promotional goods are stored.

Requirements

- 1. The cabinets should be individually lockable as there is a variety of items which will be kept separately and managed by different officials.
- 2. The type of shelving required:
 - a. Room H13: There should be a combination of shelving for lever-arch files, shelving for consumable goods, and shelving with lockable doors.
 - b. Walk-in safe: Shelving for lever-arch files and archive boxes
 - c. Science Engagement Storeroom: There should be a combination of shelving for promotional items, brochures, and small equipment. The shelving should be adjustable.
- 3. The cabinets should be easily movable on the tracks within the units.
- 4. The cabinet system should be designed to use the space optimally and provide the best solution to contain as much content as possible, yet allow for movement in the storeroom
- 5. The cabinet system should enable the officials to store as much as possible but also allow for movement within the storeroom for unpacking and arrival of goods
- 6. The cabinet system must be secure and allow for effective management of access
- 7. The cabinets should include an adjustable shelfing arrangement
- 8. The cabinets should have sturdy handles
- 9. The left and right side should be movable units
- 10. The rocking force on the unit should be light
- 11. Each rack should have a braking device to assist when unit filled to capacity
- 12. Transmission should be bearing driven

SANSA requires bidders to submit a proposal including design, and a pricing proposal for the supply and fit of high-density filing cabinets for storage as above.

5 EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1000 000 (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R1000 000) is not the Budget Amount for this Project but is the Treasury threshold for request for quotation (RFQ).

The procedure for the evaluation of responsive tenders is price, functionality (quality) and preference method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria (Table 1) and the minimum threshold of 70 points explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below

Quality/Functionality:

Scores will be tabulated to 100 points. Respondents must score **70 points** and over to be assessed on their financial offer and preference score.

Eligibility Criteria

To be eligible for the functionality, price and preferencing evaluation, the bidder must submit the following as per table 2 below. If the answer is "No" on the Table 2 below, the bidder who didn't submit the required document (s) with their bid will be requested in writing to submit them within three (3) working days for inclusion in the Bid Evaluation Committee item, if a bidder fails to submit on the 3rd working day, the relevant bid will be rejected.

7. SUBMISSION OF PROPOSALS

- a. Proposals submitted by companies must be signed by a person duly authorised.
- SANSA will award the contract to qualified bidder(s) whose proposals determined to be most advantageous to SANSA, taking into consideration the technical (functional) solution, price and BBBEE.

8. PRICING PROPOSAL

- a. The Pricing Proposal must be cross-referenced to the sections in the Technical Proposal. Any options offered must be clearly labelled. Separate pricing must be provided for each option offered to ensure that pricing comparisons are clear and unambiguous.
- b. The price needs to be provided in South African Rand (incl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- c. Payment will be according to the SANSA Payment Terms and Conditions.

9. APPOINTMENT OF SERVICE PROVIDER

- a. The contract will be awarded to the bidder who scores the highest total number of points during the evaluation process, except where the law permits otherwise.
- Appointment as a successful service provider shall be subject to the parties agreeing to mutually acceptable contractual terms and conditions.
 In the event of the parties failing to reach such agreement, SANSA reserves the right to appoint an alternative supplier.

- d. Quotation must reflect a cost breakdown, where applicable, prices quoted must be inclusive of VAT
- e. All pages of quotation must be signed by the responsible person
- f. SANSA has the right to withdraw any quotation at any time within the validity of the quotation.
- g. SANSA reserves the right to invite suppliers/companies to present their bid proposals for final decision
