- 3.1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

4. SCOPE OF WORK (TERMS OF REFERENCE)

SANSA will renovate the kitchen of the student accommodation at the Space Science facility in Hermanus, Western Cape, during the weeks **10 October to 6 November 2022.** Daily catering for lunch and supper are required, and one (1) service provider is sought who can deliver on all meals required during this period. After week two we will confirm the need of catering on a weekly basis as the renovation timeline might alter. The required meals are listed in the table below.

4.2. EVALUATION CRITERIA

Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R90 000 (all applicable taxes included) and

therefore the 80/20 system shall be applicable.

Please Note: the above amount (R90 000) is not the Budget Amount for this Project but is the Treasury threshold for request for quotation (RFQ).
