B. REQUEST FOR PROPOSAL FOR ELECTRIC FENCE SERVICES

1. BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

2. SCOPE OF WORK (TERMS OF REFERENCE)

SANSA is seeking to appoint a preferred supplier for Electric Fence Services including installation, maintenance, repairs, replacement and servicing on an as and when required basis for a three (3) year period. The services are required at the **SANSA Hermanus Facility** located at SANSA in the Western Cape. The appointed supplier will be required to enter into a SLA with SANSA.

SANSA currently has a six (6) strand, 4 km long **electrical fence** as a perimeter barricade for the SANSA Hermanus Facility. This mechanism is used to deter ingress to the property.

The services rendered must be done in a sustainable cost-effective manner whilst minimising downtime and ensuring safety, functionality, effectiveness and compliance to legislations for all electrical installations.

The successful bidder shall provide all necessary equipment, test equipment and labour to perform the required installation, inspection, testing and commissioning of equipment.

Specifications of current electric fence:

- 2 x Druid 8J Energisers (SABS Approved Specifications)
- Strands are 100mm apart
- Tension wire used plastic springs with stainless steel hooks
- Marine grade wire (316L) 1.6mm stainless steel (industry norm 1mm)
- Current flow aided by all the end and loop wires ferruled together
- Fence divided into four (4) zones
- Backup Batteries 4 – 8 hours (to be checked by supplier and advised on replacement)
- Electrical Fence signage (SABS specification), spaced 10m apart
- 7 000 – 8 000 volts
- Fence tamper proof wired to set off siren

- Earth looped with A grade earth spikes
- Issue COC on completion of every service and repair

NOTES:

- 1) The above specification pertains to the existing fence which needs to be maintained and serviced.
- 2) The servicing should include the Energisers.
- 3) The awarded supplier will be expected to do emergency repairs (when required) , as well as to provide new and additional installations should they be required.
- 4) This RFQ is for a preferred supplier for the SANSA Hermanus Facility, and the bidder will need to demonstrate the ability to provide the service at that site.

C. EVALUATION CRITERIA

SANSA promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

The procedure for the evaluation of responsive tenders is **price, functionality (quality) and preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of **80 points** explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below

2. Eligibility Criteria

To be eligible for the functionality, price and preferencing evaluation, the bidder must submit the following as per table 2 below.

If there is “**No**” on the Table 2 below, the bidder who didn't submit the required document (s) with their bid will be requested in writing to submit them within three (3) working days for inclusion in the Bid Evaluation Committee item, if a bidder fails to submit on the 3rd working day, the relevant bid will be rejected.

3. Quality/Functionality:

Scores will be tabulated to 100 points. Respondents must score **80 points** and over to be assessed on their financial offer and preference score.

The allocation of points for the evaluation of quality/functionality is set out in Table 3 below:

Evaluation criteria 1: Company Experience

Provide a detailed list of installation, maintenance, repairs and services successfully completed over the past five (5) years and on-going project/s with similar scope of this document, include the duration of each project and contract periods.

0	Bidder did not provide details of any projects or provided details of less than five (5) projects
20	Bidder provided details of five (5) to ten (10) electrical fence services, repairs, maintenance, or installation projects similar to that requested in the scope of work
40	Bidder provided more than ten (10) electrical fence services, repairs, maintenance, or installation project similar to that requested in the scope of work

Evaluation criteria 2: Response times

Response times refers to emergencies whether during working hours or after hours. The Fence provides intruder security for staff and students living on site and poses a significant security risk when the system is down. Strict adherence will be applied on a contractual level with appointed supplier.

Criteria	Maximum Points
0	Bidder is unable to respond to emergency call-outs, or there is not enough information provided to determine the response time. Either one will result in a score of 0.
10	Bidder responds to emergency call-outs and can get to site in more than 3 hours from the time when instruction is given to commence with emergency repairs (Provide proof of address and estimated km's in space provided below)
20	Bidder responds to emergency call-outs and can get to site in more than 2 hours but less than 3 hours from the time when instruction is given to commence with emergency repairs (Provide proof of address and estimated km's in space provided below)
30	Bidder responds to emergency and can get to site within 2 hours from the time when instruction is given to commence emergency repairs (Provide proof of address and estimated km's in space below)
