## **B. REQUEST FOR PROPOSAL FOR THE LEASING OF COFFEE MACHINES FOR A PERIOD OF 24 MONTHS FOR SANSA HERMANUS**

### **1. BACKGROUND TO SANSA**

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

### **2. SCOPE OF WORK (TERMS OF REFERENCE)**

The leasing of two (2) coffee machines is required for SANSA Hermanus for a period a 24 Months. The machines must be able to perform the espresso brewing process, allowing the coffee machine to make speciality coffees to professional barista standards.

The service provider must provide details of a comprehensive, proposed solution which includes but not limited to the following:

- Two identical Coffee machines with 24 menu selections, each offering 150 cups a day, or equivalent. Must provide a variety of options, which include but are not limited to: Cappuccino, Espresso, Hot Chocolate, Lattes, Mochaccinos, Black/White Coffee, Tea, Hot Water, Frothed Milk etc. The machines will be placed in different locations on the Hermanus campus.
- Free installation and full maintenance plan (no cost to SANSA) for the duration of the contract.
- The proposal should include the provision of consumables/supplies, which includes, but not limited to coffee, sugar, milk, hot chocolate etc. This would be on an as and when required basis.
- Swap faulty/dysfunctional machines and collect and repair at no cost to SANSA Hermanus. Replace all items damaged in transit at no cost to SANSA. Co-ordinate and schedule the installation from inception to completion. Perform quality assurance and control of the units until final inspection and handover.
- Machine must comply with approved SABS standards.

- The coffee machines will be rented and maintained for a period of 24 months.
- Suppliers are invited to present different options for the management of the machines in their proposals (e.g. straight use; coin, token or scanning options; management of consumables etc.).
- The service provider must train SANSA Hermanus team members on the correct use, cleaning and daily usage maintenance requirements.
- SANSA Hermanus is located at Hospital Street, Hermanus in the Westcliffe suburb of Hermanus, and the service provider must be in a position to supply and service the area.

## C. EVALUATION CRITERIA

SANSAS promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSAS is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

**Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.**

The procedure for the evaluation of responsive tenders is **price, functionality (quality) and preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of 70 points explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.

## 1. Preference

Specific goals for this RFP and number of points are indicated as per the table 1 below.

Proof of the specific goals below must be attached and submitted with the bid document in order to qualify for the preference points (specific goals).

- e. SANSA reserves the right to invite bidders to present their bid proposals for final decision or visit the bidders' premises as part of the evaluation process.
