B. REQUEST FOR QUOTATION FOR THE PLACEMENT OF SANSA ADVERTS

1. BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

2. SCOPE OF WORK (TERMS OF REFERENCE)

The South African National Space Agency (SANSA) requires a suitably qualified service provider to undertake the placement and implementation of advertising in various advertising platforms related to the business of SANSA.

SANSA requires a suitably qualified service provider to undertake the placement and implementation of advertising in various advertising platforms according to the below scope of work. SANSA will request items from the Scope of Work on an as and when required basis over a period of 6 months. SANSA's request may extend beyond the list of publications listed below, and SANSA will confirm the publication with the awarded service provider prior to placement. The supplier would be responsible for booking the advert placement of the material and paying for the placement, while it remains SANSA's responsibility to supply the material to the publication, except in cases where the publication does the design work. Based on the list below it would be advantageous to group the publications – that belong to the same publication house – in order to access discounts.

C. EVALUATION CRITERIA

SANSA promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.
