## **B. REQUEST FOR QUOTATION FOR FLOOD LINE AND HYDROLOGICAL ASSESSMENT.**

### **1. BACKGROUND TO SANSAS**

The South African National Space Agency (SANSAS) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to coordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

### **2. SCOPE OF WORK (TERMS OF REFERENCE)**

#### **SCOPE OF WORK**

- Identification & description of any sensitive receptors within the project area.
- Provide a Meteorological & Hydrological evaluation detriment to 1:50 and 1:100-year flood line or extents through hydraulic modelling.
- Service provider to propose a Stormwater management master Plan/layout in line with 2-10-100-year storm events. **(climate analyses ,rainfall designs ,storm water ponds ,catchment area, erosion control plan )**
- Service provider to conduct area screening to identify any critical/potentially fatal flows and environmental sensitive areas /receptors that may result in project delays.**(Sewers, sensitive ecological areas, surface water ,utility corridors ,wetlands)**
- Conduct hydrological studies for 2 boreholes (yield test, water analyses) & drilling which will be used for human consumption.
- Service provider shall conduct an analyses to determine impacts to the watercourse traversing the facilities access roads and recommend ways to divert /channelling away from antenna sites

## **C. EVALUATION CRITERIA**

SANSAS promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below
