1. BACKGROUND TO SANSA

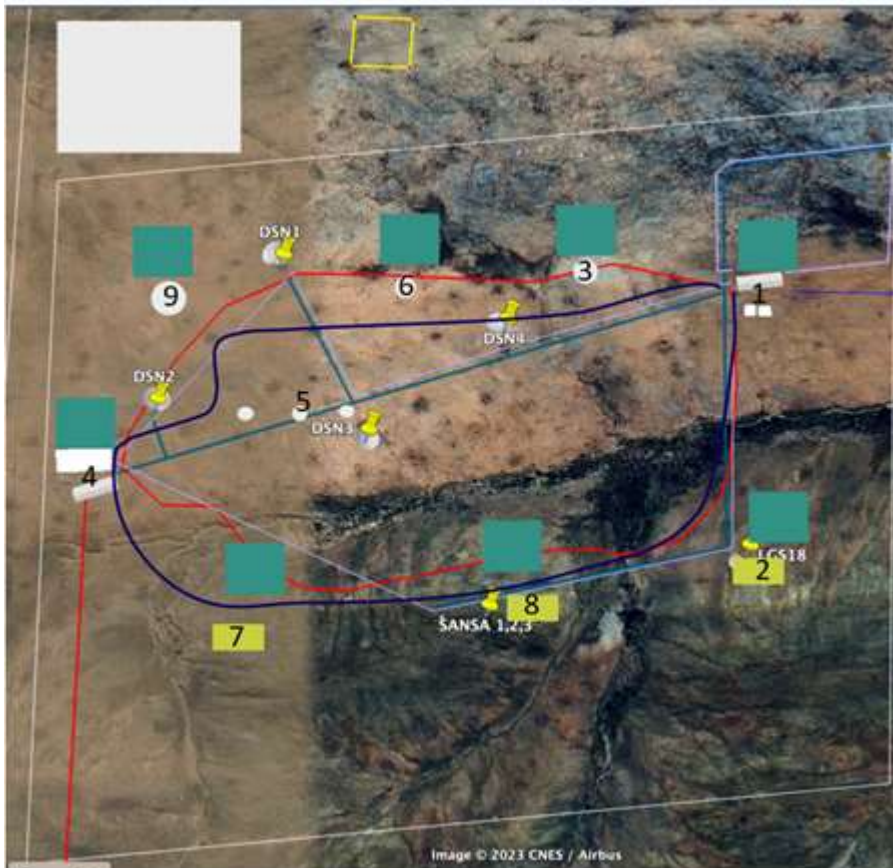
The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

2. SCOPE OF WORK (TERMS OF REFERENCE)

There is a new ground station, communication facility to be located in the Matjiesfontein area in the Western Cape province. SANSA requires the services of a

1. Desk study to obtain – if available – historical data on geotechnical and hydrogeological conditions. Test pit excavation (2m deep), soil profiling and sampling of key horizon for relevant laboratory analyses.
2. Test pit excavation (maximum 10)
3. Addressing of the potential geological concerns
4. Preliminary Draft Report within 1 month
5. Programme of works and submission of final report (incl. e.g., lab results, etc. necessary to finalize the report)
6. Detail breakdown of costing e.g. cost per pit.

Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the Table below
