# B. REQUEST FOR QUOTATION FOR TRANSPORT OF SANSA HERMANUS SHIFT WORKERS

The South African National Space Agency (SANSA) requires the services of a service provider to deliver a shuttle service to SANSA shift workers for a period of one (1) year with an option of a month-to-month extension not exceeding 12 months, in Hermanus, Western Cape, South Africa.

## 1. BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

# 2. SCOPE OF WORK (TERMS OF REFERENCE)

- To provide transport service for shift workers from points of residence to SANSA daily (24/7/365) and from SANSA to the residence.
- The vehicles must be able to transport at least 2 6 shift workers at a time
- Vehicles must be clean and in good working order at all times, service records should be up to date and readily available (vehicles will, periodically, be inspected by SANSA Facility Services).
- Drivers must be in possession of valid driver's licence plus PDP at all times.
- Service must be available as required (similar or equivalent to UBER / BOLT)
- Drivers to be vetted by SANSA (name and identification and licence to supplied)
- Vehicle insurance should include transportation of passengers/third party insurance (evidence of insurance to be provided throughout the service period)

**Location:** The location of transport service is Hermanus, Western Cape (specifics to be communicated once secured).





# C. EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.
