# B. REQUEST FOR QUOTATION FOR THE APPOINTMENT OF AN ENGINEER (ENGINEERING COMPANY) TO PROVIDE RENEWABLE ENGINEERING SERVICES.

#### 1. BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programs and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa.

South African National Space Agency requests a proposal from an experienced Engineer/ Consulting firm to Conduct Feasibility Studies, Develop and Manage the Implementation of Alternative energy solution.

SANSA is faced with Challenges of Power supply needs as we increase our infrastructure on site as well as the need to reduce carbon footprint. The entity dependents on servicing clients from all over the world as revenue generation and the demand of antennas are increasing over time. SANSA needs to increase its energy capacity to support the existing and new customers.







# 2. QUALITY CONTROL AND QUALITY ASSURANCE.

The prospective service provider must show his/ her capabilities to render the available services that are. SANS/SABS/ISO/NEMA standards to be adhered to at all costs.

#### 3. HEALTH AND SAFETY REQUIREMENTS

The successful bidder must take into account all aspects of the occupational Health and Safety Act which has been enacted to provide for the Health and Safety of person in connection with the use of tools, equipment, plant and machinery, the protection of persons against hazards to health and safety arising out or in connection with the activities of persons at work, to establish an advisory council for occupational health and safety and to provide for matters connected therewith. However, the contractor shall still be accountable for compliance and adherence to the OHS Act.

# 4. SCOPE OF WORK (TERMS OF REFERENCE).

SANSA is calling for suppliers to provide proposals, design, implementation monitoring and approvals for renewable power solution.

The Services required include the following:

- Feasibility Studies and Energy usage analysis.
- Requirement Specifications and design of the SANSA renewable power Solutions within 1 week of completing the analysis.
- Design should be a phased-based approached, modular/scalable solution
- Provide and undertake all relevant application approvals and documentation.
- Develop and provide SANSA with a financial model and Costing demonstrating proposed project benefit.
- Produce bill of quantities (BOQ)
- Preliminary project schedule.
- Project management plan.
- Service provider to guide SANSA on whether Baseline Environmental studies will be required for this project.
- Assist SANSA with the Development of tender documentation and participate on the bid specification committee (BSC) meetings.
- Provide Project Management for the implementation of the proposed option.
  - Phase 1 Construction Monitoring, Verification and Commissioning
- The construction value is estimated at +1R15M





#### C. EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.
