B. REQUEST FOR QUOTATION FOR

1. BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

2. SPECIFICATION (TERMS OF REFERENCE)

Request for Quotation (RFQ) for Physical Miniature Model of Matjiesfontein Deep

Overview:

We are seeking proposals for the creation of three (3) detailed physical miniature models of the Matjiesfontein Deep Space Ground Station. The models should accurately represent the architectural design and operational aspects of the station. The model will serve both educational and promotional purposes.

2. Scope of Work:

• Develop three physical miniature models of the Matjiesfontein Deep Space Ground Station based on the features of the architectural design (client will provide the architectural designs to the winning bidder). Of the three models, two should be the same size (larger size) and the third in smaller size.

3. Specifications:

- Model 1 and 2:
 - Size: Approximately 800mmx800mm (the actual site size is 1 KM x 1 KM).
 - Materials: Durable and lightweight for transportation.
 - Finish: Painted or textured to accurately reflect the station's appearance.
 - Portability: Designed for easy packing, safe handling, and transportation to both local and international events.
 - Include intricate details such as antennas, main building, roads, generator house, security building, control rooms and the surrounding landscape (e.g. mountains, hills, vegetation etc.).

• Model 3:

- Size: Approximately 500mmx500mm.
- Materials: Durable and lightweight for transportation.
- Finish: Painted or textured to accurately reflect the station's appearance.





- Portability: Designed for easy packing, safe handling, and transportation to both local and international events.
- Include intricate details such as antennas, main building, roads, generator house, security building, control rooms and the surrounding landscape (e.g. mountains, hills, etc.).
- Only Model 3 one should come in a suitable, high-quality storage/travel case.

4. Deliverables:

- Three physical miniature models (2x 800mmx800mm and 1x500mmx500mm)
- Storage/travel case for the 500x500mm model.

5. Timeline:

• Completion and delivery of the models to SANSA Space Operations (Hartebeesthoek) by 30 April 2025.

1. EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.
