B. REQUEST FOR QUOTATION FOR A PREFERRED SUPPLIER FOR FIRE ALARM SYSTEM SERVICING, REPAIRS, MAINTENANCE AND INSTALLATION OF NEW FIRE ALARM SYSTEMS AND EQUIPMENT FOR A PERIOD OF THREE (3) YEARS AT THE SANSA HERMANUS

1. BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

2. SCOPE OF WORK (TERMS OF REFERENCE)

The South African National Space Agency (SANSA) requires a service provider to render servicing, repairs, and/or maintenance of existing Fire Alarm Systems and Installation of new fire alarm systems and equipment for a period of three (3) years for the Hermanus site of SANSA located in Hermanus, Western Cape. The objective is to maintain the serviceability and operability of Fire Alarm System at SANSA Hermanus in a sustainable manner at the lowest operating and maintenance costs while ensuring compliance to general safety and related legislation. The specifications and requirements in this document comprise the description of the Works

2.1 The required services are:

- BI-annual fire alarm service of the Fire Alarm Systems infrastructure at SANSA Hermanus and these systems are in office buildings, accommodation buildings and other associated buildings.
- Maintenance of the Fire Alarms Systems infrastructure at SANSA Hermanus in response to a call out
- The bidder shall provide all necessary components, spares, test equipment and labour to perform the required inspection, testing, maintenance and repairs of such equipment.
- Servicing/ compliance certificates to be included after each service.

2.4 Request for servicing or installation will be done on a per quote basis. SANSA reserves the right to test the market for comparative pricing on future installations and make use of alternative service provider if the successful service provider cannot match the comparative pricing

C. EVALUATION CRITERIA

SANSA promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.

The procedure for the evaluation of responsive tenders is **price, functionality (quality) and preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of 80 points explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.

1. Preference

Specific goals for this RFP and number of points are indicated as per table 1 below. Proof of the specific goals below must be attached and submitted with the bid document in order to qualify for the preference points (specific goals).
