# B. REQUEST FOR QUOTATION FOR A PREFERRED SUPPLIER FOR INTRUDER ALARM SERVICING, REPAIRS AND MAINTENANCE AND INSTALLATION OF NEW INTRUDER ALARM SYSTEM AND RELATED EQUIPMENT FOR A PERIOD OF THREE (3) YEARS AT THE SANSA HERMANUS

# 1. BACKGROUND TO SANSA

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

# 2. SCOPE OF WORK (TERMS OF REFERENCE)

The South African National Space Agency (SANSA) requires a service provider to render servicing, repairs, and/or maintenance of existing Intruder Alarm Systems and installation of new intruder alarm systems and related equipment for a period of three (3) years for the Hermanus site of SANSA located in Hermanus, Western Cape

- 2.1 Required service include but not limited to:
  - The service provider will maintain the Intruder Alarm Systems infrastructure at SANSA
    Hermanus which consists of Office Buildings, Accommodation Buildings, and a few
    instrumentation and laboratory type buildings.
  - The service provider must be qualified to complete all the repairs.
  - The service provider shall be expected to identify all needed repairs and modifications required during a regular onsite inspection, testing and maintenance (ITM).
  - All deficiencies identified by the service provider shall be repaired and documented immediately by the service provider while on site.
  - Servicing for the intruder alarm system will be done on a bi-annual basis.
  - Servicing/compliance certificates to be included after each service.
  - Request for installation will be done on a per quote basis.
  - The system currently installed at SANSA Hermanus is **Texecom** and all repairs need to be compatible to this system.

#### C. EVALUATION CRITERIA

SANSA promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.

The procedure for the evaluation of responsive tenders is **price**, **functionality** (**quality**) and **preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of 70 points explained below. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.
- Thereafter, only the qualifying bids are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.

#### 1. Preference

Specific goals for this RFP and number of points are indicated as per table 1 below. Proof of the specific goals below must be attached and submitted with the bid document in order to qualify for the preference points (specific goals).

Note to tenderers: The tenderer must indicate how they claim points for each preference point system.
