B. REQUEST FOR QUOTATION FOR THE CATERING SERVICES FOR ICAO SPACE WEATHER WORKSHOP

1. BACKGROUND TO SANSAS

The South African National Space Agency (SANSAS) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

2. SCOPE OF WORK (TERMS OF REFERENCE)

CATERING SERVICES FOR ICAO SPACE WEATHER WORKSHOP

Hermanus, 8–12 June 2026

The South African National Space Agency (SANSAS) requires a catering service provider to supply full catering services for the ICAO Space Weather Workshop to be held at SANSAS's premises in Hermanus from 8 to 12 June 2026. Catering is required for a maximum of 60 delegates for the first two days and for 35 delegates for the last three days.

MORNING TEA

Morning tea is required each day from Monday 8 June to Friday 12 June 2026 at 10:45 and the setup should be done by 10:30, for 60 people for the first two days and 35 people the last three days. The following must be provided each morning:

Refreshments: freshly brewed filter coffee, a selection of regular and herbal tea bags including English tea and rooibos tea, fresh milk, sugar and sweeteners and bottled water. Health muffins, fruit skewers, butter and jam.

Venue: First two days in the Space Weather Centre, last three days at the Technolab.

AFTERNOON TEA

Afternoon tea is required each day from Monday 8 June to Friday 12 June 2026 at 15:00 and the setup should be done by 14:45. This is for 60 people for the first two days and 35 people for the last three days. The following must be provided each afternoon: freshly brewed filter coffee, a selection of regular and herbal tea bags including English tea and rooibos tea, fresh milk, sugar, sweeteners, and bottled water.

Rotate snacks between:

Snack 1: An assortment of biltong and droewors and vegetarian mini quiches.

Snack 2: An assortment of cheese, crackers, vegies (carrot strips, apple strips, celery strips and dips (humus and dipping sauce) and small, individual milk tarts in pastry cups.

Venue: First two days in the Space Weather Centre, last three days at the Technolab.

LUNCH

A sit-down lunch is required each day from Monday 8 June to Friday 12 June 2026. On Monday 8 June and Tuesday 9 June, lunch must be provided for 60 people. From Wednesday 10 June to Friday 12 June, lunch must be provided for 35 people.

The service provider must supply and set up all furniture and table service for the lunch function each day, including tables, chairs, tablecloths, cutlery, crockery, and glassware sufficient for the number of delegates on each respective day. Fresh flower arrangements must be placed on the tables for each day's lunch service. The service provider is responsible for the breakdown and clearing of all furniture, table service, and décor at the conclusion of each lunch service. Lunch is served at 12:30 in the Entertainment area.

GENERAL REQUIREMENTS

The service provider must supply all consumables, serving equipment, and staffing necessary to deliver the above services. All food and beverages must be of a professional conference standard. The service provider is responsible for the setup, service, and clearing of all refreshment and lunch stations each day. Waste removal and cleaning of the catering areas after each service is the responsibility of the service provider.

Meals for the first two days must include **five halaal** and **five vegetarian** options.

Meals for the last three days must include **two halaal** and **three vegetarian** options.

Lunch Menu

Lunch should be served in buffet style

Day 1: Lamb chops with rosemary gravy, roasted potato wedges, creamed spinach & rice. Vegetarian option: Cauliflower steak (thick cut, brushed with butter and herbs, grilled or roasted until golden). Dessert: malva pudding and custard

Day 2: Chicken pie, roast potato & green salad. Vegetarian option: Mushroom & Leek Pie. Dessert: Milk tart in pastry cups

Day 3: Wors, beef stew, pap and chakalaka or gravy and pumpkin fritters. Vegetarian option: lentil curry (mild). Dessert: koeksisters

Day 4: Lasagne, roast veggies, garlic bread & salad. Vegetarian option: vegetarian lasagne. Dessert: Mini cheesecake bites.

Day 5: Canape lunch including seeded crackers topped with salmon, cream cheese, capers; Mini roast beef wraps, Sirloin steak strips/skewers with dip, mini quiches (meat and veg options); Chicken strips/fried chicken, small meat balls, veg and meat samoosa's, Mozzarella/tomato/basil skewers with pesto and brownies.

In addition to the above, the service provider must book and pay for dinner at The Wine Glass for 45 people on Wednesday 10 June 2026 from 18:00. The dinner should include mains, dessert, table wine with white and red options and a soft drink for each guest.

Dinner menu:

Beef Short Rib Ragu with Pappardelle OR Linefish Oriental OR Forest Mushroom Linguie (VEG option)

Dessert: Cheesecake Lux OR Hazelnut & Orange Chocolate Torte

6 x tables seating

C. EVALUATION CRITERIA

SANSAS promotes the concept of "best value" in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSAS is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.

The procedure for the evaluation of responsive tenders is **price** and **preference** method. The evaluation of the bids will be conducted in the following two stages:

- Firstly, the submission will be evaluated to confirm if it meets the required scope of work as stated above. A bid will be disqualified if it fails to meet all the requirements for the scope of work.
- Thereafter, only the qualifying bids (meet the scope of work) are evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.

1. Preference

Specific goals for this RFP and number of points are indicated as per table 1 below. Proof of the specific goals below must be attached and submitted with the bid document in order to qualify for the preference points (specific goals).

- e. SANSA reserves the right to invite bidders to present their bid proposals for final decision or visit the bidders' premises or contact the references as part of the evaluation process.
